

# SPONSORSHIP OPPORTUNITIES

#### Introduction

Parks and Recreation is a committee of Pierson Township whose services are primarily funded from the township general fund. Significant funding from a combination of sources built the foundation for the Pierson Township Community Park. The Township wishes to add amenities, and develop future programing to further enhance its ability to deliver services to the community and provide enhanced levels of service beyond core funding from the general fund through sponsorship.

#### **Policy Statement**

It is the policy of Pierson Township (Parks and Recreation) is to seek sponsorships for its events, parks, programs, and amenities from individuals, foundations, corporations, non–profit organizations, service clubs and other entities. The purpose of sponsorship is to increase the ability to maintain facilities, deliver services to the community, and provide enhanced levels of service from beyond the general fund.

In appreciation of such support, Pierson Township will provide sponsors with suitable acknowledgement of their contributions. However, such recognition shall adhere to the aesthetic values and purpose of the township parks, facilities, and programs. Additionally, such recognition shall not detract from the user experience, or shall it impair the visual qualities of the site, or be perceived as creating a proprietary interest. This policy is not applicable to gifts, grants, or unsolicited donations for which no benefits are granted to the donor and where no business relationship exists between the donor and the township.

#### Sponsorship

Sponsorship is an investment in cash and/or in kind, in return for access to exploitable business potential associated with an event or worthwhile cause.

Honor a loved one by sponsoring a tree. Trees will be maintained by the township landscaper to flourish and grow with the park.

After purchase, the contact person will receive confirmation of the planting location and plaques will be ordered in sets of 2.



6 ft Bench with 2 lines engraving \$1,415.00



#### **Pavilion**

Pierson Township will be raising funds to build a shelter for picnic tables, add tables, and provide needed shade for the Community Park. This will also become a rental source for future park maintenance and operation costs.

The approximate need will be \$150,000 for the structure, concrete, and tables.

#### **Guiding Principles**

The following principles shall form the township's consideration for sponsor proposals:

- Sponsorship shall relate to the intent and/purpose of the facility, park, or program being sponsored.
- Sponsorships will not result in any loss or the Pierson Township authority.
- The mission of a sponsor organization should not conflict the mission of the Parks and Recreation Committee or of Pierson Township.
- Sponsorships cannot be made conditional on the performance of the Parks and Recreation Committee or Pierson Township.
- Sponsorships provide a positive and desirable image to the community.
- Sponsorship benefits offered should be commensurate with the relative value of sponsorship.
- Acceptance of a sponsorship will not limit the committee's ability to accept other sponsorships from other individuals.

- Recognition benefits to be offered must compromise the design standards and visual integrity of the park or facility.
- An evaluation of the potential sponsor shall include but is not limited to:
  - Consideration of any immediate or initial expenditure required in order to accept the sponsorship;
  - The potential and extent of the township's obligation to maintain the sponsorship;
  - The community benefit derived from the sponsorship; and
  - ♦ The ethical appropriateness of the sponsorship.

Organizations are not eligible for sponsorship if they relate to any of the following:

- Companies whose business is substantially derived from the sale of alcohol (excludes businesses that serve prepared food on site), tobacco, marijuana, firearms or pornography.
- Organizations with noncommercial messages, such as religious or political institutions.
- Any business regarded as an "Adult" business.
- Any depiction that gives the appearance or impression that a product or business is endorsed or recommended by the township or its officials, officers, agents, or employees.
- Sponsorship that creates a conflict of interest or policy with the Township.

Sponsorship Categories: Sponsorships are appropriate for the following broad types of activities and require approvals:

**Events:** financial or in-kind support for an event organized by the Parks & Recreation support that facilitates the ongoing Committee on township owned or managed property. Approval by the Pierson Township Board or designee.

Recreation Programs: financial or in-kind delivery of a particular township or sitespecific recreation program. Approval by the Pierson Township Board or designee.

Authority Levels: The Township Board possesses sole and final decision-making authority for determining the appropriateness of a sponsorship. The Township reserves the right to refuse any offer of sponsorship.

The following form the basis of sponsor recognition:

- The Parks and Recreation Committee and Pierson Township Board appreciate all sponsorships that enable it to further its mission.
- In recognition of a sponsor's contribution levels, a certificate or plaque for their business.
- Recognition of a sponsorship shall not suggest in any way the endorsement of the sponsor's goods or services by Pierson Township or the Parks and Recreation Committee, or any proprietary interest of the sponsor.
- Any physical form of on-site recognition shall not interfere with visitor use or routine program, event, and facility organization.
- The form of any on-site recognition shall be of an appropriate size and color and shall not detract from the park surroundings or any interpretive message and its subject to approval from the board and from any lessor of any township facility located on land leased to the township.
- All sponsorship agreements will be for a defined period of time relative to the value of the sponsorship and the life of the asset being sponsored.
- Naming of events and/or facilities within a park or community center in recognition of a sponsor is permitted providing such names are subordinate to the name of the recreation amenity.

#### **Recognition of Sponsors:**

These guidelines have been established to ensure all sponsors are treated in an equitable and appropriate manner and that in recognition of a sponsor's support, the value and purpose of a particular community facility and/or park is not diminished.

The guidelines contained within this policy do not apply to gifts, grants, and/or donations for which there is no benefit or recognition.

#### Types of Recognition:

- A thank you letter
- Publicity through the Pierson Township Website, social media, newsletters, media releases, and any other applicable public outreach.
- Events such as a press conference, photo opportunity, groundbreaking, or ribbon cutting ceremony.
- Commissioner acknowledgement at civic functions.
- Commemorative items, such as a frames, pictures, or plaques.
- Acknowledgement on printed materials, such as recreation brochures.
- Inclusion of the individual's name or company name and logo on a sponsorship donor/recognition wall at a Parks & Recreation facility.
- Where on-site recognition is to be provided, types of recognition may include:
  - ⋄ Temporary signs, which may include use of logos, acknowledging a sponsor \* to the extent permitted by the township sign ordinance.
  - Interpretive sign, which may include the use of logos \*
  - ♦ Permanent plaque or sign (permanency is limited to the life of the asset).

The Township Board will determine the type of recognition and has the right to terminate sponsorship should conflict arise.
