RESOLUTION TO APPROVE ROAD SPECIAL ASSESSMENT BALLOT LANGUAGE TO BE PLACED ON THE NOVEMBER 8, 2022 BALLOT.

WHEREAS, The Pierson Township Board wishes to provide Road Improvements, Maintenance and Repair, and;

WHEREAS, the Township may provide road maintenance and repair, as authorized by PublicAct 62 of 1933, MCL 211.203; and

WHEREAS, the Township may contract and cooperate with other entities to provide road maintenance, repair and improvements, as authorized by the Michigan Constitution of 1963 and other laws, and;

WHEREAS, the Township Board deems said Road Funding Assessment to be fair, just and equitable, and that each of the assessments contained thereon is relative to the benefits to be derived by the parcel of land assessed.

WHEREAS, the Special Assessment shall be levied each year for a period of 4 years, for the years 2023 through 2026 inclusive.

NOW THEREFORE BE IT RESOLVED; The Pierson Township Board approves the Road Funding Special Assessment proposal ballot language, shall be placed on the **Tuesday**, **November 8**, **2022 ballot** and shall read as follows:

PROPOSAL 1 ROAD FUNDING SPECIAL ASSESSMENT

Shall Pierson Township levy special assessments pursuant to Article IX, Sec. 6 of the Michigan Constitution, at the rate of one and one half (1.5) mill (\$1,500 of taxable valuation) upon all taxable real property within the unincorporated portion of Pierson Township, Montcalm County, Michigan (i.e. that portion outside the Village of Pierson) for a period of four (four) years, 2023 through 2026, inclusive for the provision of road improvements, maintenance and repair within that unincorporated area of the Township? If approved and levied, one and one half (1.5) mill is estimated to raise \$218,349 in the first calendar year of the levy.
