FROM THE ASSESSOR

Tax bills may adjust not only based on the Interest Rate Multiplier (IRM), but also based on a taxing authority's millage rates. Be sure to review your parcel to see if you qualify for any exemptions (Poverty, Disabled Veterans, Principal Residence, or Qualified Ag., etc.). Remember that new construction affects both assessed and taxable values. Connect with me if you would like an estimate on the tax implications, or if you feel that the property's assessed value seems too high, we can review your record card for accuracy. If you still disagree, you may appeal your assessment to the March Board of Review.
