# FILING OF SPECIAL ASSESSMENT ROLL FOR SPECIAL ASSESSMENT DISTRICT; NOTICE OF PUBLIC HEARING

WHEREAS, the Township Board, pursuant to Act 188 of the Public Acts of Michigan of 1954, as amended ("Act 188") has resolved its intent to renew and make public improvements consisting of the paying and sealing of West Hillis Road in the Township (the "Improvements"); and

WHEREAS, following a public hearing on August 18, 2025, which hearing was duly noticed in accordance with Act 188, the Township Board adopted a resolution to establish the West Hillis Road Improvement Special Assessment District (the "District"), approved the renewal of the Improvements for the District, and directed the Township Supervisor to prepare a Special Assessment Roll for the District.

### NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. The special assessment roll for the District, (the "Special Assessment Roll"), as reported to the Township Board by the Township Supervisor, shall be filed in the office of the Township Clerk and shall be available for public inspection during the normal office hours of the Township office.

- 2. The Township Board shall hold a public hearing on September 15, 2025 at 7:00 p.m., at the Township Hall, located at 21156 Cannonsville Road, in said Township, to review the Special Assessment Roll and hear any objections to it.
- 3. The Township Clerk shall cause to be published a notice of the hearing and the filing of the Special Assessment Roll in the *Daily News* (*Greenville*), being a newspaper of general circulation within the Township, at least two (2) times prior to the hearing with the first publication at least ten (10) days prior to the time for hearing and a proof of publication of such notice shall be filed with the Township Board.
- 4. The Township Clerk, at least ten (10) days prior to the date of the hearing, shall send a notice of the hearing by first class mail addressed to each record owner of, or party in interest in, each parcel of land to be assessed, at the address shown for such record owner or party in interest upon the last Township tax assessment roll for ad valorem tax purposes which was reviewed by the Township Board of Review, as supplemented by any subsequent changes in the names or addresses of the owners or parties listed thereon (except in the case of railroad companies, who shall be mailed a notice of the hearing by registered mail within five (5) days after the first publication of the notice in Paragraph 3, above); provided that if a record owner's name does not appear on the Township tax assessment records, then the notice required by this paragraph shall be given to the record owner at the address shown by the records of the Montcalm County Register of Deeds.
- 5. The notice of the hearing to be mailed and published as set forth herein shall be substantially in the form set forth in Exhibit A hereto.

- 7. All resolutions or parts of resolutions in conflict herewith shall be and the same are hereby rescinded.

An appearance may be made by an owner or party in interest, or his or her agent, in person or, in the alternative, an appearance or protest can be filed with the Township by letter prior to the hearing, in which case a personal appearance at the hearing is not required.
